

- Phasing of Adjustments

Policy 8130 - Local School Boundaries and Program Assignments

Summary of Impact of Policy Changes

New Policy 8130 benefits the community because it:

- Clearly states implementation belongs to the Division Superintendent to depoliticize process of determining potential changes
- Provides for 5-year cyclical review to maximize effective use of facilities and delivery of excellent education
- Prioritizes the critical criteria including proximity that must be followed with additional criteria recommended for potential consideration
- Strengthens public input and engagement requirements
- Strengthens board oversight by requiring full School Board approval of any adjustment, with exceptions for temporary emergencies

Community Data Input by Priority Areas

Task 1: Review and Highlight (Individual)

- Review the summary report: Familiarize yourself with the key themes in the summary report.
- Highlight Key Points: Use highlighters or sticky notes to mark statements or themes that stand out.

Task 2: Synthesis and Analysis (in Groups)

- Accuracy Check: Do some spot checks to validate that these reports align with what you see in the scanned notes. Is anything missing or overstated?
- Implications: What are the top themes the community wants FCPS to address for your assigned priority? Are there clear "must-haves" or "must-avoids"?

Task 3: Next Steps Brainstorming

 Prompt: Based on these themes, what are the actions or recommendations for FCPS as we move from data collection into data analysis and boundary scenario creation?

Instructions:

- Brainstorm possible ways to integrate the community feedback into boundary scenarios.
- Identify any additional data or research needed to address the community's concerns.

Closing

 Summary: Agreement by committee members on summary of decisions and confirmation of key takeaways / discussion points.
