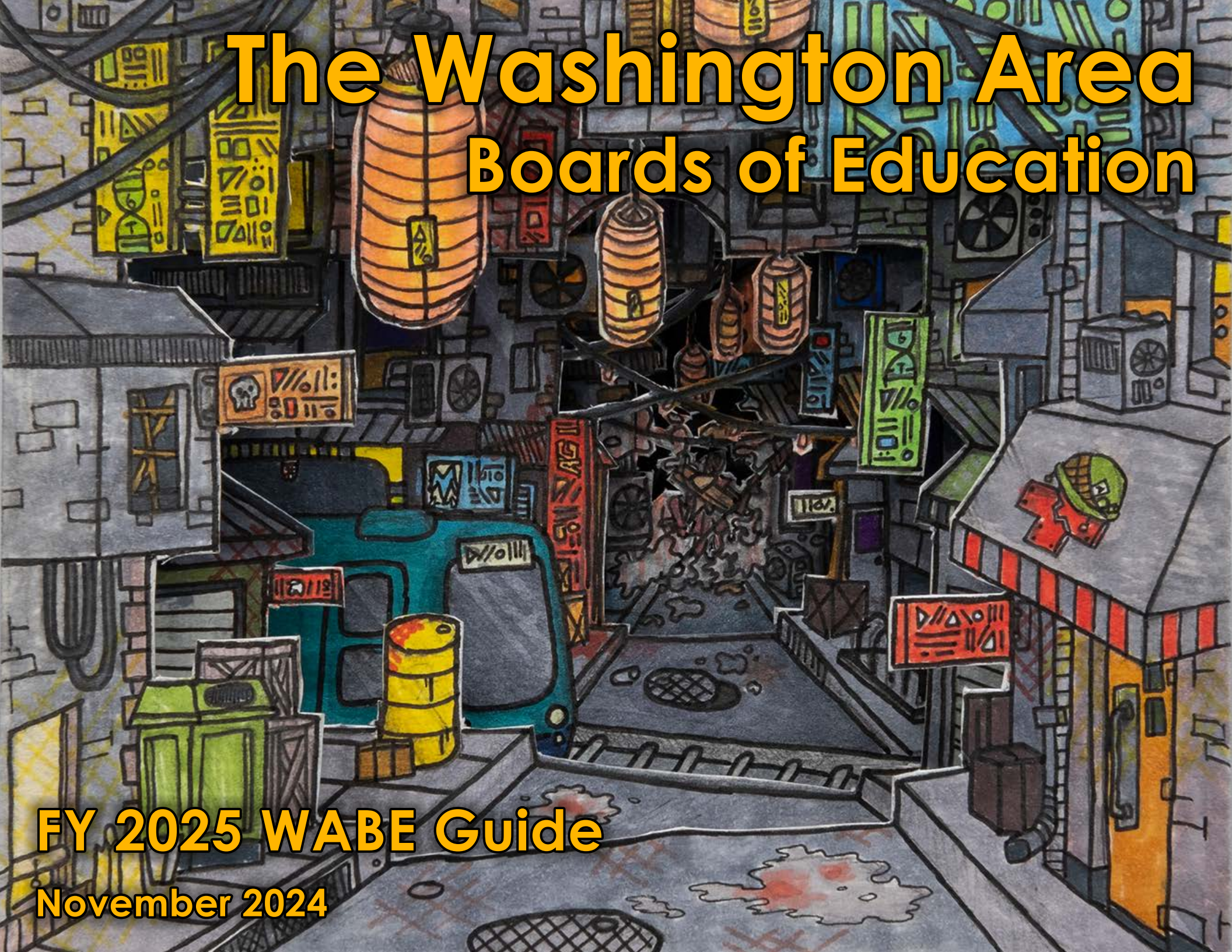

Alexandria City Public Schools

- Alexandria City Public Schools (ACPS) serves more than 16,000 students, from more than 119 countries and who speak 121 languages. ACPS has 18 schools, including two middle schools, two K-8 schools, one pre-K school and the internationally recognized Alexandria City High School (ACHS).
- ACHS had 905 graduates who will attend over 135 universities, serve in the military, work at a job or learn a technical vocation. Of the 905 graduates, 427 graduated with an advanced studies diploma.
- The Scholarship Fund of Alexandria awarded 216 students scholarships totaling \$644,800 for their first year of college, to be renewed throughout their four years of study, totaling \$2,330,300 in value.
- Thirty Titan athletes signed letters of intent to compete in collegiate athletics in nine sports.
- The Titan Class of 2024 received \$2,000,000 in merit scholarships.
- ACHS had two 2024 National Merit Scholarship Program recipients, each earning \$2,500 scholarships
- Two ACHS Class of 2024 students were among the 400 recipients nationwide this year to receive an Amazon Future Engineer Scholarship.
- The ACHS Class of 2024 had a Dell Scholarship recipient.
- ACPS' 2024 on-time graduation rates improved to the second highest rate seen in 10 years, up four percentage points to 87 percent from the prior year. ACPS' dropout rates decreased four percentage points to 9percent in the same year.
- ACPS is included among the Forbes list of America's Best-In-State Employers 2023 in the Commonwealth of Virginia.
- An ACHS senior was selected as the winner of the Harry F. Byrd Jr. Leadership Award from Virginia's 8th Congressional District.
- The Titan Robotics Team at Alexandria City High School (ACHS) came up with a big win at the 2024 FIRST Robotics District Championship hosted by Virginia State University.
- The ACPS Financial Services team was awarded the Association of School Business Officials International Certificate of Excellence in Financial Reporting for the FY 2022 Annual Comprehensive Financial Report.
- ACPS was recognized with 15 awards from the National School Public Relations Association.
- ACPS received a Metropolitan Washington Council of Governments (COG) 2023 Climate and Energy Leadership Award for its School Bus Electrification Project.
- The National Institutes of Health (NIH) awarded ACPS \$497,830 to provide middle school students with an after-school STEM experience.

Arlington Public Schools

- Niche.com ranked Arlington Public Schools (APS) the #1 best places to teach in the Commonwealth of Virginia, #2 best school district in Virginia and #3 in the Washington DC Metropolitan area, and fifteen schools ranked among top schools, including Dorothy Hamm Middle School, which was named the #1 best middle school in Virginia.
- Arlington Public Schools is fully accredited by the Virginia Department of Education (VDOE) for the 2023-24 school year.
- Three APS high schools were ranked among the top 2 percent of schools in the nation in the Jay Mathews Challenge Index, a nationwide ranking of U.S. high schools.
- U.S. News and World Report released its list of top high schools, including Yorktown, which ranked #12 in Virginia, and Washington-Liberty, which ranked #20.
- APS students outscored their peers both nationally and at the state level on SAT and ACT scores and IB Pass Rates.
- APS has more than 220 National Board-Certified Teachers and is in the top 25 nationally for the number of new NBCTs.
- The Class of 2023 has 86 percent continuing with post-secondary.
- The APS Class of 2023 earned \$85.5 million in scholarships.
- Of the APS graduates, 62 percent earned an advanced degree.
- The On-Time Graduation Rate was 97.7 percent.

City of Fairfax Public Schools

- Since 1962, the City of Fairfax School Board has contracted with Fairfax County Public Schools (FCPS) for the delivery of educational services. The City School Board owns and is responsible for its school buildings, while FCPS is responsible for instructional services and staffing within the schools.
- The City of Fairfax School Division is comprised of four buildings housing some 5,000 students in grades PreK-12. About 3,000 of these students are residents of the City of Fairfax with the remainder residing in Fairfax County.
- City of Fairfax Schools include:
 - Daniels Run Elementary School (DRES) and Providence Elementary School (PES) completed major renovations in 2000. Both schools provide STEM/Innovation Labs and sophisticated outdoor classrooms. DRES and PES offer Local Level IV Advanced Academic Programming for students starting in the 3rd grade. In addition, our two elementary schools provide laptops for each student in grades 4-6. School capacity for DRES is 850 students and PES is 1,000.
 - Katherine Johnson Middle School (KJMS), often recognized for the rigor of its academic program, completed an extensive renovation in the spring of 2008. KJMS has a capacity of 1,100 students and offers a full Advanced Academic Center. The school hosts a solar wind turbine, the first in the nation for a middle school. KJMS was recently recognized by the U.S. Department of Education as a National Green School and has been a Virginia Naturally School for eleven consecutive years.
 - Fairfax High School (FHS), renovated and rededicated in the fall of 2007, is an academic and arts showcase. Offering students, a challenging academic program, including a full range of AP courses, advanced technical programs as well as the specialized programs of the Fairfax Academy for Communications and the Arts, graduates are fully prepared for their futures. FHS capacity is 2,450.

Fairfax County Public Schools

- Fairfax County Public Schools (FCPS) is the nation's 9th largest school division.
- The FCPS Strategic Plan provides a framework for decision-making that builds upon a common mission, vision, and guiding principles held by the community. The Portrait of a Graduate is the center of the strategic plan.
- Thomas Jefferson High School for Science and Technology (TJHSST) was ranked fifth by U.S. News and World Report in 2023 as the nation's best high school. Additionally, TJHSST was ranked fourth for the best science, technology, engineering, and math (STEM) school. The following FCPS high schools: Langley, McLean, Marshall, Oakton, and Woodson were also included in the top 10 schools in Virginia.
- In 2024, Sangster Elementary and Thomas Jefferson High for Science and Technology, received the Virginia Board of Education Highest Achievement Award. Schools recognized for highest achievement were "Accredited" and demonstrated high levels of success across all school quality indicators, including narrowing of achievement gaps.
- Three FCPS high schools: Lewis, South Lakes, and West Potomac earned the 2024 Board of Education Continuous Improvement Award.
- Ninety-nine percent of FCPS schools, compared to 89 percent statewide, earned full state accreditation from the VDOE based on the results from the Virginia SOL tests administered during the 2022-2023 school year.
- In 2024, 264 FCPS students from 15 high schools were named semifinalists, and 23 students from seven FCPS schools were winners in the National Merit Scholarship Program after taking the Preliminary SAT/National Merit Scholarship Qualifying Test.
- FCPS is the largest employer in Fairfax County, with 25,743.7 full-time employees.
- The FCPS bus fleet is one of the largest in the United States, transporting more than 130,000 students on over 1,625 buses each day.
- FCPS has more than 28 million square feet of school buildings and office space, including 187 schools that have earned ENERGY STAR® certification at least one time.

Falls Church City Public Schools

- Falls Church City Public Schools (FCCPS) is a small, independent, city school division established in 1949.
- All five FCCPS schools are fully accredited:
 - Jessie Thackrey (PreK - Special needs preschool program)
 - Mount Daniel Elementary (K-2)
 - Oak Street Elementary (3-5)
 - Mary Ellen Henderson Middle (6-8)
 - Meridian High (9-12)
- FCCPS is one of the few school divisions in the nation to offer The International Baccalaureate (IB) Programme PreK-12 and is an IB Continuum School Division.
- FCCPS consistently scores above state and national averages on standardized tests. Overall FCCPS SOL pass rates for the 2023-2024 school year are:
 - Math 89% - Tied for #1 (in VA)
 - Writing 94% - Tied for #5
 - Reading 92% - Tied for #1
 - History 88% - #1
 - Science 89% - #1
- The FCCPS student body is multi-cultural with students speaking over 30 native languages.
- Historical Accomplishments
 - FCCPS was a pioneer in Virginia school divisions, providing 6 weeks of paid parental leave for employees with a new child (2024).
 - FCCPS was the first Virginia school system to offer the challenging International Baccalaureate curriculum for high school students (1981).
 - FCCPS was one of the first Virginia school systems to develop a before and after-school daycare program for children of working parents (1975).
 - FCCPS was the first Virginia school system to offer full-day kindergarten (1973).
 - FCCPS was the first Virginia school system to voluntarily integrate schools (1961).

Loudoun County Public Schools

- Loudoun County Public Schools (LCPS) welcomed Dr. Aaron Spence as its new superintendent in September 2023. During his first year as LCPS Superintendent, Dr. Spence engaged with LCPS parents, staff, and the community in a county-wide listening tour.
- During the 2023-24 school year, more than 82,000 students were enrolled in LCPS, and the division employed over 13,000 staff. The LCPS graduating Class of 2024 included 6,758 seniors. Nearly 74 percent of graduates reported that they will attend a four-year college in the fall, while almost 15 percent will attend a two-year school. More than \$64 million in scholarships were awarded to LCPS graduates this year.
- Two LCPS high schools are officially authorized as International Baccalaureate World Schools offering the IB Diploma Programme during the 2023-24 school year.
- LCPS was among 1,335 schools nationwide to receive the 2023 EVERFI Empowered Seal, indicating that LCPS is among the top 10 percent of school districts in the U.S. and Canada for its commitment to whole-child education.
- For the 13th consecutive year, LCPS earned the 2024 ENERGY STAR Partner of the Year Award for Sustained Excellence from the U.S. Environmental Protection Agency (EPA) and the U.S. Department of Energy. LCPS is the only school system that has 13 years as a Sustained Excellence Partner.
- All 17 LCPS middle schools have been designated as Schools to Watch by the National Forum to Accelerate Middle Grades Reform. In addition, five LCPS middle schools are among 23 schools nationwide that received the Schools of Distinction Award from the Association of Middle Level Education.
- Twelve LCPS schools have been awarded the Purple Star recognition for demonstrating military-friendly practices and a commitment to military-connected students and families.
- Niche ranked Waxpool Elementary as Virginia's Best Elementary School. Goshen Post Elementary was ranked the third-best elementary school in Virginia. In addition to these two schools, 12 other LCPS elementary schools made the top 100 list.
- Four LCPS students represented the division at the Regeneration International Science and Engineering Fair, the world's largest pre-college STEM competition in May 2024 in Los Angeles, California. In addition, two Loudoun County Public School students were named 2024 U.S. Presidential Scholars. These students are among the 161 students from around the country selected for the honor.
- LCPS partnered with Amazon Web Services to launch a Think Big Space at J.L. Simpson Middle School in December 2023. During the 2023-24 school year, students and educators from around the county and around the region utilized the Think Big Space to explore innovative and imaginative ideas through interactive, hands-on technical education and cloud computing training.

Manassas City Public Schools

- Baldwin Elementary School is a Project Lead the Way Distinguished School. Dr. Laura Goldzung, former Baldwin principal and now principal of Haydon Elementary, was also named the 2021-22 PLTW National Administrator of the Year. Project Lead the Way is also offered in grades 5-12.
- A K-12 CTE & STEM program is offered in all schools. Some of the Osbourn High School programs include Cyber Security, Engineering, Auto Technology, Cosmetology, and a variety of business courses.
- MCPS offers has an extensive work-based learning programs where students can receive on the job training and experiences in relevant industries through business partnerships.
- MCPS offers an Integrated Math and Science Program and an Integrated Humanities Program grades 7-10. Algebra 1, Geometry, and World Language are offered at the middle school level for high school credit.
- Osbourn High School serves as a Governor's STEM Academy, the first in the Greater Prince William region, with specialized pathways in Facility and Mobile Equipment Maintenance, Cybersecurity, and Engineering Technology.
- Osbourn High School is a Grammy Award winner as well as a Virginia Music Educators Association's (VMEA) Blue Ribbon Award recipient, the highest award given to school music programs in Virginia recognizing school performing arts programs that achieve excellence in Band, Orchestra, and Choral performance.
- MCPS students can attend the Governor's School @ Innovation Park, which offers advanced college-level STEM courses to juniors and seniors on the Prince William Campus of George Mason University.
- George Mason University and Northern Virginia Community College provide opportunities for students to experience college-level academics and obtain college credit through dual enrollment.
- Early learners are afforded the opportunity to participate in the Virginia Pre-School Initiative through a traditional half-day program at each MCPS elementary school.
- Robotics, VEX, SeaPerch, and "It's Academic" teams promote high-level independent thinking and essential teamwork skills.
- Band, Orchestra, and Chorus are offered beginning in 5th grade, and Guitar is offered beginning in 7th grade.
- Metz Middle School was the first school in Northern Virginia to be Nearpod Certified for its successful implementation of the interactive learning platform.

- MPCS is committed to engaging students through powerful learning experiences!
- A partnership with the Capital Area Food Bank allows MPCS to distribute more than 50,000 pounds of food to families during the school year. Staff members from all four schools, administration, and the City of Manassas Park come together at Manassas Park High School to volunteer their time to organize and distribute food to families.
- Serve the medical needs of the uninsured, MPCS partners with George Mason University and surrounding health care providers to offer the Mason and Partners (MAP) Clinic at the Manassas Park Community Center.
- MPCS continues to train its staff on ALICE – Alert, Lockdown, Inform, Counter, and Evacuate – a set of proactive strategies that moves beyond lockdown and increases the chance of survival during a violent intruder event.
- The Early Identification Program (EIP), in partnership with George Mason University, has approximately 45 MPCS students in the program. It promotes higher education to potential first-generation college students.
- All students grade K-12 are provided opportunities to participate in STEM education. These programs are supported by The BELL Foundation, the education foundation for Manassas Park.
- The city's diversity extends into the school system where students come from 52 countries around the world.
- MPCS participates in the Regional Governor's School @ Innovation Park.
 - Manassas Park High School offers a Certified Nursing Assistant program as part of its Career and Technical Education program. Students can now take a track to graduate with a certificate to become a CNA.
 - Manassas Park City Schools is continually expanding its diverse range of Work-Based Learning opportunities, offering students real-world experiences through initiatives like Coffee with Contractors, Aviation Career Day, Service-Learning projects, and offering EMT experiences.
- Manassas Park City Schools launched a new five-year strategic plan to engage all students in powerful and meaningful learning experiences.
- MPCS has a K-8 curriculum to teach social and emotional learning to all students.
- MPCS recently partnered with the City to install new safety and security upgrades in all school buildings including enhanced security cameras, access controls, and ballistics materials.

Prince William County Public Schools

- Prince William County Public Schools' (PWCS) preliminary on-time graduation rate for the 2023-24 school year is 94.3 percent, a 2.6 percent increase over the previous school year, and the English learners' on-time graduation rate is 80.6 percent, a 9.6 percent increase over the year prior.
- PWCS' overall dropout rate for the 2023-24 school year decreased by 2.7 percent and the English learners' dropout rate decreased by 9.6 percent.
- Student attendance is a key indicator for student academic success. PWCS' chronic absenteeism rate for the 2023-24 school year was reported as 16.2 percent, a 5.4 percent reduction from the prior year.
- For the 2023-24 school year, PWCS saw improvements in SOL scores across all subjects, surpassing the state's averages in nearly every category. Students achieved a 76 percent score in reading, which is 3 percent above the state average and 1 percent higher than the previous year. In writing, students scored 79 percent, marking a 3 percent increase over the state average and an 8 percent rise from the 2022-23 school year. History and social sciences scores reached 71 percent, 6 percent higher than the state average and 1 percent above the previous year. Math scores were 73 percent, 2 percent higher than both the state average and the prior year. Finally, students scored 68 percent in science, a 2 percent improvement from the 2022-23 school year.
- Access to advanced academic coursework has increased by 9 percent and over 12,000 career and technical education credentials have been earned by PWCS students.
- The PWCS class of 2024 earned more than \$123 million dollars in scholarships, nearly a \$4 million dollar increase from the year prior.
- The Virginia Department of Wildlife Resources (DWR) recognized 13 Prince William County Public Schools as Virginia Naturally Schools for the 2023-24 school year.
- Seven Prince William County Public Schools were recognized as 2024 America's Healthiest Schools by the Alliance for a Healthier Generation.
- Six PWCS students have been selected as 2025 National Merit® Scholarship Program Semifinalists.
- Prince William County Public Schools Superintendent Dr. LaTanya D. McDade was named Region IV Superintendent of the Year. This recognition comes after a unanimous nomination by her Region IV colleagues.
- Two PWCS high school seniors received the prestigious Congressional Gold Medal Award from the U.S. Congress.

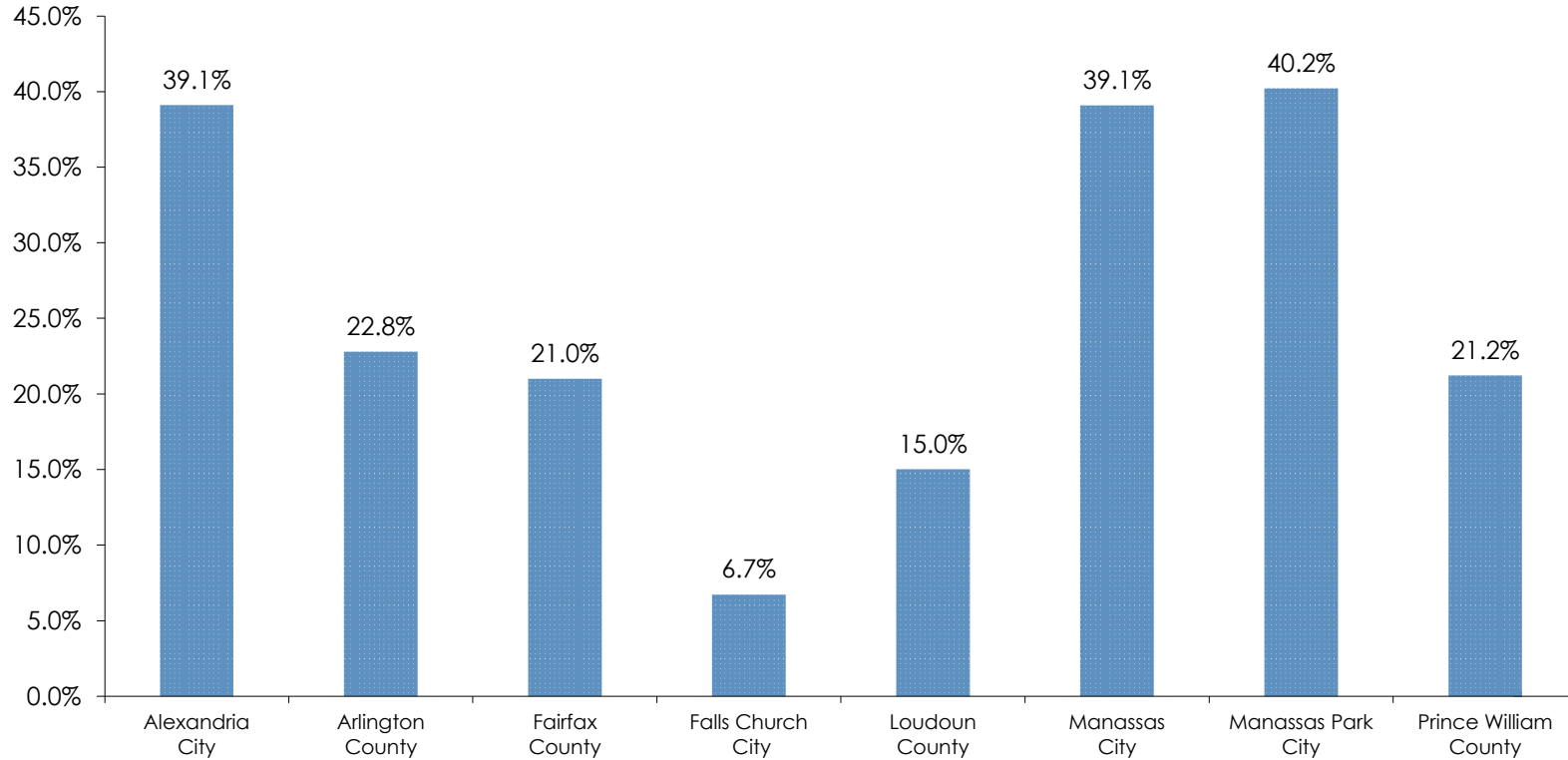

FY 2025 Expenditure Data Definitions

Operating Fund or Budgeted Current Expenditures:

The data in this category include all funds for day-to-day expenditures for operation of the school system such as regular and special education instruction; may include grants such as Head Start, ESSA, Impact Aid, Perkins, and grants associated with IDEA; transportation costs including costs for new and replacement buses; and building maintenance for educational programs. Budgeted current expenditures also include the employer's share of employee benefits whether paid by the school district, municipality, or the state. The expenditures are typically funded in the school operating fund.

Construction and Renovation:

This category includes all expenditures (which are typically funded in a capital improvements fund or budget) for land, new construction, major renovations, and relocatable classrooms, whether funded by the school district, municipality, county, or state through bond sales or "pay-as-you-go" expenditures.

Debt Service:

This category includes all payments for principal and interest on long-term debt whether paid by the school district, municipality, county, or state.

Food Service:

This data includes all expenditures for the school food services program regardless of the funding source (federal, state, and local subsidies; and food sales).

Other Governmental Funds:

This category includes other Governmental Funds expenditures not included elsewhere, such as:

- Grants budgeted in a fund other than those listed previously
- Adult education, defined as any remedial, enrichment, or makeup course or program offered outside of the regular school year
- Summer school, defined as any remedial, enrichment, or makeup course or program offered outside of the regular school year
- Other expenditures not defined elsewhere and defined within the chart

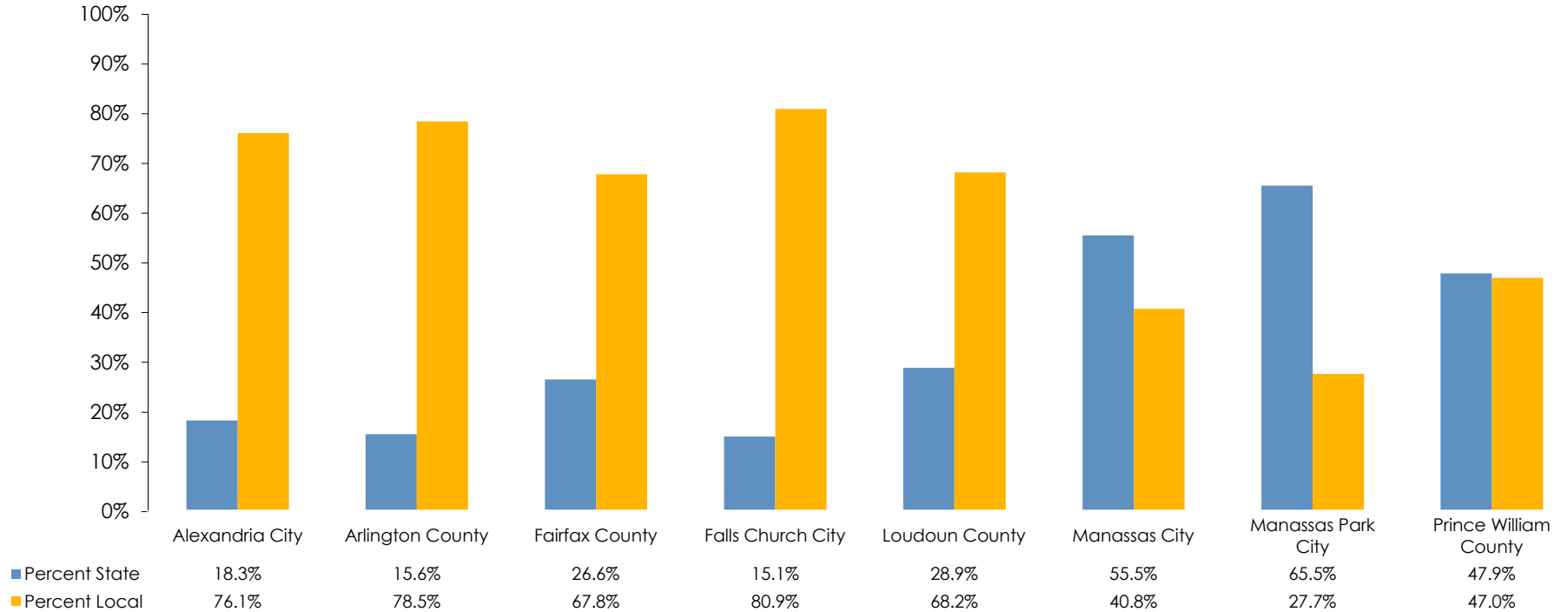
