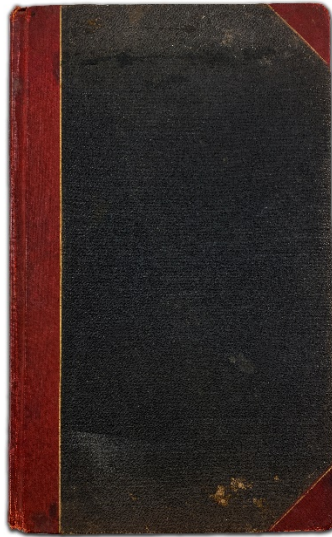

A note on transcriptions:

A line-by-line transcription has been prepared to preserve the integrity and style of the original writing. Modern usages of punctuation and capitalization have been used for the sake of readability. Shorthand versions of “and” in the form of plus signs instead of ampersands have been preserved, the various notations of money have been unaltered, and names, many in abbreviated form as was the fashion of the time period, have been transcribed as they appear with only the addition of necessary punctuation for consistency.

 or teacher of School No. 2, at \$35 - thirty five dollars
 per month, and A. T. Shirley as teacher of
 School No. A, at \$35 - thirty five dollars per month.

 menced their respective schools - upon motion
 the Clerk was instructed to put up notices asking
 for bids for furnishing ten cords of wood for
 the white schools and five cords for colored school.
 The wood to be hard wood either 4ft long or cut into

The employment or selection of teachers for the ensuing term was taken up. There being but two applicants for Grade No. 1, Mr. J. F. Brawner was selected, salary fixed at sixty dollars per month. A. T. Shirley was selected as teacher for the negro school, salary fixed at thirty-five dollars per month. The fixing of length of term and employment of primary teachers was deferred 'till [sic] next meeting.

Clerk was instructed to advertise for bids to furnish wood to booth [sic] schools also to advertise for janitor for white school. Next meeting set for July 12th. Clerk was directed to inform Mr. Garrett of time & place of meeting and urge attendance. There being no further business meeting adjourned.

School board met at the residence of W. H. Taylor. By reason of the two newly selected trustees a reorganization of the board was first in order, W. H. Taylor was reelected chairman and Frank W. Huddleson clerk. The minutes of the previous meeting were read and approved.

Moved & carried that three teachers be employed for the white school 2 voting for and one against.

Miss R. O. Fulton was chosen as teacher for the intermediate grade at a salary of \$30⁰⁰ per month. Miss V. E. Wrenn was selected for the primary grade at a salary of \$25⁰⁰ per mth. The contract for 15 cords of wood was given to A. Bradley, 12 cords oak @ \$3⁰⁰ 3 cords pine @ 2⁵⁰ - 10 cords to be delivered to the white school and five cords to the negro school.

The bids for painting negro school were not satisfactory & rejected.

Clerk was appointed to have belfry erected cost not to exceed \$25⁰⁰.

W. H. Taylor & John McNabb were appointed committee to investigate conditions of grounds adjacent negro school and report if open drain, fill in or build walk as they deemed best. There being no further business meeting adjourned.

Clerk was appointed to have belfry erected, cost not to exceed \$25⁰⁰.

W. H. Taylor & John McNabb were appointed committees to investigate conditions of grounds adjacent negro school and ~~report~~ & open drain, fill in or build walk as they deemed best. There being no further business, meeting adjourned.
