# 6. Education for Independence: Status of Funding for FY 2017 - Sheryl Granzow

There are currently no updates regarding Education for Independence: Status of Funding for FY 2017. Sheryl Granzow wrote a letter to Senator Tim Kaine's office and has a meeting scheduled for September 29 to discuss the needed funds to continue this program.

ACEAC made a motion to reach out to Mr. Moon and request the full grant amount of \$80,000.00 – the committee approved the motion. Mrs. Williams and Mrs. Passman will coordinate a letter.

# 7. Workforce Innovation and Opportunity Act and Region 8 AEFLA Grant - Update

**Linda Seyer**, AEFLA Regional Grant Manager, hopes to receive an update regarding the Workforce Innovation and Opportunity Act by next meeting, October 19, 2016. The State is late on getting information out because there have been many transitions within the Virginia Office of Career, Technical & Adult Education.

### 8. Adult ESOL – Update on Willston Multicultural Center "Replacement"

**Linda Seyer** read an update from MaryAnn Cunningham Florez, Adult ESOL, about the move from the Willston Multicultural Center to the Graham Road Community Building (GRCB).

"The move to Graham Road has been completed, and we are working hard to make sure everything is in place for the start of classes on September 26. Adult ESOL will hold morning classes in 5 classrooms on the second floor of GRCB that have been cleaned. Evening classes will be held in 4 classrooms on the mezzanine level that were renovated several years ago by another program. We will share the space on the mezzanine level with Transitional ESOL High School (TEHS), which holds classes in those same classrooms in the mornings.

The majority of furniture and materials were moved on September 21. We were able, with the help of Facilities Management Personnel, to leverage workable furniture from Willston, Leis, Graham Road itself and the warehouse, as well as some additional tables purchased by ESOL Services, to cover the 5 classrooms that we have on the second floor and our second floor and mezzanine offices. The four (4) classrooms on the mezzanine level were furnished through the efforts of TEHS and ESOL Services. While we may initially have to limit our classes a little in number due to available furniture, we are hopeful in the future that we can find resources to augment the furniture.

The community response to classes in the Graham Road location has been very good, with many calls and inquiries coming into our offices. We have held testing and pre-registrations for both morning and

evening sites and have had very good turnout for both. We expect to run at least 4, probably 5 classes in the morning, and 4-6 in the evening.

We are very grateful to ISD for the funds provided to make this move possible on relatively short notice. The deteriorating conditions at Willston forced our hand and as a result of the short notice, and a lack of discretionary funds in the Adult ESOL budget, some challenges remain. For example, we will need to add to our furniture (mainly tables and chairs) to accommodate the enrollment targets that we normally require to financially support our classes (an average of 22 students per class per site is the minimum). There are also emerging infrastructure (security, custodial, technology) needs at Graham that programs using the center are being told they will need to help support. But we are glad to improve on the conditions at Willston."

# 9. Adult High School Completion - GED Test Update - Brad Rickel

The Adult High School Completion staff is waiting for the State to announce the additional tests the State will offer alongside the GED test. Brad Rickel, Adult High School Administrator, mentioned the GED test will be adding additional test sites to make it more convenient for their students. Mr. Rickel highlights how the GED test is not an end-point. If students complete the GED program, they still have the option to continue their education and/or enter the military.

## 11. FY 2015-16 ACEAC Report Recommendations Update

**Recommendation 1:** Advise the School Board to support a viable location for the FCPS Adult ESOL Program in the Seven Corners-Baileys' Crossroads Area of Mason District.

• **Update for Recommendation 1** – Adult ESOL classes were moved from the Willston Multicultural Center to Graham Road Community Building. The community reaction so far has been positive. There is a shortage of funds to complete the Graham Road transition.

**Recommendation 2:** Advise the School Board to appropriate additional funds for Adult and Community Education for a permanent counselor.

• **Update for Recommendation 2** –There has not been any further discussion for this recommendation. The staff encourages keeping the recommendation.

Karin Williams, Director of OSPC, said ACE can cost out a counselor position and encouraged the committee to reach out to Mr. Moon providing him with information as soon as possible.

**Recommendation 3:** Advise the School Board to appropriate additional funds for Adult High School Completion (AHSC) programs to support the new GED requirements to ensure increased pass rates for students. The School Board should encourage and support opportunities for GED staff to participate in professional development at the local, regional, and/or state level.

• **Update for Recommendation 3** – Currently, the GED staff is taking professional learning classes available online on Tuesday evenings. Ann Wyllie would like to send her staff to

additional staff development training that is not restricted to online classes. The staff encourages keeping this recommendation.

The 2016 ACEAC Staff Response will be provided on BoardDoc. Amanda Redman will provide the link when it becomes available.

### 12. ACE: Community Education component: Start of Classes Update, etc.

Sheryl Granzow, ACE Administrator, gave a brief update about the start of classes within ACE. The Apprenticeship and Adult and Community Education classes have increased enrollment slightly compared to previous years.

This year, the Herndon Learning Center location has experienced a higher volume of registrations compared to previous years. Currently, ACE has a waitlist for the daytime classes in the Herndon Learning Center. ACE staff is mindful of the current trend and will pay attention if there is a continuation of the trend.
