Make time for fun!



Make Adjustments (Accommodations) as Needed

- Voice to text
- Spell check & no spelling penalties
- Copy of teacher notes
- Keyboarding
- Audio books
- Small group testing
- Extended time
- Hard copies of textbooks





Refuel the Sensory System

- Noise cancelling headphones
- Stand/pace/move during class
- Specific seating needs
 - o wobble stool, location
- Gum, water bottle, snacks
- Advance notice of fire & other drills
- Flash pass
- Quiet space for breaks
- Alternate location for lunch
- Early/late access to locker room







Go, you! Collaborate!

- Always first approach
- Share information
 - allow communication between school & private providers
- Communicate concerns & agenda topics in advance of meetings





Yellow before red!

- Ask questions
- Seek clarification


Presume positive intent



Hazard Ahead!

How to recognize signs of trouble and what to do about it







Hazard Sign: Change in child's affect, attitude or behavior

at home, during social activities or at school

- Talk to your child
- Contact:
 - Teacher
 - School counselor
 - School social worker
 - School psychologist
 - High school Hazel Mental Health



Hazard Sign: Change in responsiveness from school

- Copy additional people on your emails
- Contact:
 - Teacher
 - Department chairs
 - School administration & if needed, progress up the admin chain to:
 - Executive Principals (by Pyramid)
 - Regional Assistant Superintendents (by Region)
 - Central Office Specialists
 - Ombudsman's office





Hazard Sign: Increase in disciplinary concerns

(note: monitor SIS notifications)





- Keep a discipline log of all communications, dates, and event details
- Refer to FCPS SR&R
- Contact school staff:
 - Teacher
 - Case manager
 - Administration
- Determine if there are unmet needs, lagging skills, bullying or other concerns

Hazard Sign:

Increase in disciplinary concerns, continued





- Consider a Functional Behavioral Analysis (FBA)
- Seek help from a Behavior Intervention Teacher (BIT)
 - BITs are central office specialists trained in behavior and problem solving
 - Every school has a BIT assigned to them
 - BITS can be requested by the school team or parent
- Develop a Behavior Intervention Plan (BIP) with the IEP or 504 team
- Always be aware that BEHAVIOR IS COMMUNICATION
 - What is your child trying to tell you?









Hazard Sign:

Missing data or disagreements about progress reports

- Contact case manager
 - Request data records
- Request a meeting to discuss progress reports
- Put your concerns in writing and address them to the case manager





Do ALL instructors know about IEP or 504 & accommodations?



Remember: specials teachers, elective teachers, discipline staff, administrators & others...



Student- or parent-developed 1-pager





Recess - unstructured, social setting



Lunch - volume, smell, taste, crowd, setting, social, lack of structure and guidance



PE - competition, sensory processing, overwhelm, locker room, dressing out, fine motor skills







- Creatively brainstorm
 - Stay open-minded!
 - Keep trying!
 - Don't get stuck on one solution!
- Just because it hasn't been done before doesn't mean it can't be done!






Detours & GPS: LESS COMMON ROADS

- Residential programs





Detours & GPS: WILD CARD SOLUTIONS!

- Homebound & Home-Based Services
 - with teacher
 - via Edmentum
 - partial or full-time
- Hybrid Programs
 - splitting day between programs (CSS & general education)
- Private Options
 - schools
 - online (e.g. Virginia Virtual Academy (VAVA), Virtual Virginia)
- Opting Out
 - GED, unschooling, etc.






